RESOLUTION 15-02

A RESOLUTION ADOPTING FIRE AND LIFE SAFETY INSPECTION FEES

A RESOLUTION OF THE DESTIN FIRE CONTROL DISTRICT, OKALOOSA COUNTY, FLORIDA, CREATING FIRE AND LIFE SAFETY INSPECTION FEES FOR THE SERVICE PROVIDED TO INSPECT COMMERCIAL AND MULTI FAMILY RESIDENTIAL PROPERTIES TO DETERMINE COMPLIANCE WITH THE FLORIDA FIRE PREVENTION CODE.

WHEREAS, THE DESTIN FIRE CONTROL DISTRICT BOARD OF FIRE COMMISSIONERS IS GIVEN THE POWER PURSUANT TO SECTION 191.009 (3)(d) OF FLORIDA STATUTES AND SECTION 9 (3)(d) OF CHAPTER 2000-417, LAWS OF FLORIDA TO ADOPT RULES AND REGULATIONS NOT INCONSISTENT WITH ANY PORTION OF THE ACT AS IT MAY DEEM NECESSARY IN THE TRANSACTION OF ITS BUSINESS AND IN CARRYING OUT THE PROVISIONS OF THIS ACT, MAY PROMULGATE AND ENFORCE REASONABLE FIRE REGULATIONS BY RESOLUTION.

BE IT SO RESOLVED BY THE DESTIN FIRE CONTROL DISTRICT, OKALOOSA COUNTY, FLORIDA:

SECTION 1: DEFINITIONS

As used in this regulation the following terms shall have the following meanings:

- a. <u>Inspector</u>: Means the Inspector or a designated representative.
- b. <u>Re-Inspection:</u> Means a follow up to a previous inspection where a violation has been noted.
- c. <u>Fees:</u> Means the assessment of a monetary charge authorized pursuant to this resolution.

SECTION 2: FEES SCHEDULE

The following fees shall apply to each Fire and Life Safety Inspection. A fee will be charged for every re-inspection in which the violation is not corrected.

1st Inspection:

No Charge

Re-Inspection with violation correction:

No Charge

Re-inspection without violation correction

SECTION 3: LIMITATIONS AND RESTRICTIONS

a. The Destin Fire Control District shall only bill for those services rendered by Destin Fire Control District.

SECTION 4: COLLECTION AND ENFORCEMENT

- a. The District Fire Chief, or the Chief's delegates, shall collect and properly account for the Fire and Life Safety Inspection Fees imposed by this Resolution, and may establish such documents and procedures as are reasonably necessary to carry out the intent of this Resolution.
- b. The Fire and Life Safety Inspection Fees collected under this Resolution shall be general revenue of the District.

SECTION 5: EFFECTIVE DATE

THE CHARGES WILL BECOME EFFECTIVE March 10, 2015.
