### Specifications for Destin Beach Safety ATVs, UTV, and Waverunner

#### **1.0 INTENT**

It is the intent of this specification to provide for the purchase of three all-terrain vehicles, one utility task vehicle and one waverunner.

The Destin Fire Control District will receive proposals for the purchase of three ATVs, one UTV and one waverunner until January 4, 2019, at 12 noon CST. All proposals received must be marked on the outside of the envelope **2019 ATVs. UTV and Waverunner** and meet the specifications as described herein.

The Destin Fire Control District (DFCD) has evaluated different styles of ATVs, UTVs and Waverunners and has determined that this published specification is best suited for the DFCDs needs in terms of quality and features. This specification shall not be interpreted as restrictive but rather as a measure of quality and performance against which all other systems will be compared.

In comparing proposals, comparison will not be confined to price only. The successful proposer will be one whose product is judged as best serving the interest of the DFCD when price, product, quality and delivery are considered. The DFCD also reserves the right to reject any or all proposals or any part thereof, and to waive any minor technicalities.

#### 2.0 EQUIVALENT PRODUCT

Proposals will be accepted for consideration on any structure that is equal or superior to the equipment specified. Decisions of equivalency will be at the sole interpretation of the DFCD. A blanket statement that equipment proposed will meet all requirements will not be sufficient to establish equivalence.

#### **3.0 INTERPRETATIONS**

In order to be fair to all proposers, no oral interpretations will be given to any proposer, as to the meaning of the specification documents or any part thereof. Every request for such a consideration shall be made in writing. Based on such inquiry, the DFCD may choose to issue an Addendum in accordance with local state laws.

#### 4.0 GENERAL

The specification herein states the minimum requirements of the DFCD. All proposals must be regular in every respect. Unauthorized conditions, limitation, or provisions shall be cause for rejection. The DFCD will consider as irregular or non-responsive any and all proposals that are not prepared and submitted in accordance with the proposal document and specification, or any proposal lacking sufficient technical literature to enable the DFCD to make a reasonable determination of compliance to the specification. It shall be the proposer's responsibility to carefully examine each item of the specification. Failure to offer a completed proposal or failure to respond to each section of the technical specification will cause the proposal to be rejected without review as non-responsive. All variances, exceptions and/or deviations shall be fully described in the exceptions and deviation section of the proposal. Deceit in responding to the specification will be cause for rejection.
