## Presentation of September 30, 2020 Audit Report by Carr, Riggs & Ingram

Steve Riggs with Carr, Riggs & Ingram presented the September 30, 2020 audit to the Board stated it was a clean opinion. #### **Review of Minutes**

The minutes of the Regular Meeting of March 9, 2021, Special Meeting of March 17, 2021 and Special Meeting of March 31, 2021 were presented. Commissioner Green made a motion to approve the minutes as presented, seconded by Commissioner Wagner. With no further discussion, the motion passed unanimously.

## **Review of Financial Report**

## **Old Business**

a. West End of District Station – Chief Sasser advised the Board that he received a basic drawing from DAG for the Bay House with a very generic layout for housing. Commissioner Green asked to table the drawings until the next special meeting in order to get a more detailed drawing of the living quarters.

Discussing ensued on zoning of the property. Chief Sasser noted that it has gone before the City for a first reading and is scheduled for a second reading sometime in April, 2021.

Further discussion ensued on the dock area, boat slips and the basic needs of the property to be operational July 1, 2021. Chief Sasser advised the Board that a security company has been secured to provide cameras, etc. for security on the property.

b. <u>Emergency Medical Services (EMS)</u> – Chief Sasser requested the item be removed from the agenda. Chairman Moore noted the item will be removed and brought back before the Board at a later date.

#### **New Business**

- a. Request for Proposals Bank Qualified Tax-Exempt Loan Division Chief Wagner advised the Board that the District received only one (1) response, reviewed the proposal from Synovus Bank and recommends the Board approve Division Chief Wagner to negotiate the terms with this lending institution and bring options before the Board at a later meeting. Commissioner Wagner motioned to approve Synovus Bank as the lender, seconded by Commissioner Green. With no further discussion motion approved unanimously.
- b. Resolution 21-06 Mid-Year Amendment to 2020-2021 Adopted Budget

Chief Sasser advised the Board that the Mid-Year Budget Amendments will come before the Board at the next Regular Meeting.
