Review of Minutes

a. <u>West End of District Station</u> – Chief Sasser advised the Board that after the pre-submittal meeting / tour of the new fire station, several potential contractors requested additional time to submit a bid for the

<u>CARES Act Funding Okaloosa County</u> – Chief Sasser advised the Board that the Okaloosa County Commissioners approved a grant and issued a check payable to the District for \$40,000.00. Chief Sasser reviewed the requirements of the County to accept the grant.

<u>Budget Workshop for 2021/2022 fiscal year</u> - Division Chief Wagner reviewed the projected preliminary assess from Okaloosa County Property Appraiser and requested the Board set the millage rage at 1.000 for the 2021/2022 fiscal year. Commissioner Wilson motioned to set the proposed mileage rate at 1.000, seconded by Commissioner Green. With no further discussion the motion passed unanimously.
