Review of Minutes

a. West End of District Station – Chief Sasser advised the Board that team members are now running calls from the new fire station and he will begin providing the Board with response times next month to show the positive impact the station is making responding to the needs of our community and visitors.

New Business

<u>Budget Workshop for 2021/2022 fiscal year</u> — Chief Sasser reviewed the Budget Summary provided by Division Chief Wagner. Discussion ensued between Chief Sasser and Board members regarding the upcoming budget workshops and the Board agreed to include a budget workshop with the July 28th, 2021 Special Meeting.

Request for Proposals 21-006 – Remodel of Fire Stations and Design-Build of Apparatus Bay – Chief Sasser advised the Board that the District received 1 RFP that conformed to our RFP guidelines from Bear General Contractors. Attorney DC Matthews advised the Board they could reject the one (1) bid per Statutes and negotiate in good faith with one (1) or more vendors on the services and goods needed per FL Statutes 287.057. Discussion ensued over the negotiating committee. The Board determined the three (3) members of the committee would be Chief Sasser, Commissioner Buckingham and Attorney DC Matthews. Commissioner Wagner motioned to reject the one (1) bid, seconded by Commissioner Wilson. With no further discussion, the motion passed unanimously.
